#### Forest Fire Smoke and Your Health

Along with the pleasant days of summer comes the risk of forest fires. Sometimes even with distant fires, or even fires in neighboring provinces, we can have smoke conditions in our communities. Forest fire smoke can have an effect on our health, especially if we already have lung disorders.

If you notice smoke in the air, you are reminded to monitor your local radio station for forest fire updates. The following measures can be implemented especially if we have lung or heart troubles, are elderly or very young:

- Remain indoors during times that there is smoke in the air
- Keep doors and windows closed if cooling is needed, use a fan or air-conditioner.
- \* Don't smoke and avoid exposure to second hand smoke.
- \* If you have room air cleaners with HEPA filters, turn them on.
- \* Reduce exercise and activity, especially outdoors.
- \* Don't use wood stoves, gas stoves, and even candles. Don't fry or broil food. These can make the indoor air quality worse.
- \* When you are in your vehicle, keep the windows closed and put the air system on 'recirculate' so you don't suck smoky air inside.
- \* Be aware that outdoor events, especially athletic games or competitions, may be postponed or cancelled if smoke levels are elevated.
- \* If you are on lung or heart medicine, always keep at least a 5-day supply on hand get a refill of your prescription prior to running out of your medication.
- \* If you have neighbors, friends or relatives who live alone, check periodically to make sure they are ok. Elders and people with heart or lung conditions may get sick from the smoke.
- \* If you are experiencing increasing symptoms, more than irritation in the eyes, nose or throat, call the HealthLine at 811 or see your local health worker.

If smoke becomes a significant problem, your local community may set up a site in the community that has access to air conditioning such as a school or community hall, so continue to listen to your local radio station for updates.

During any forest fire season in small northern communities, it is wise to be prepared in case fire becomes an immediate threat in your community - pack one change of clothing, personal toiletries, and health card for each family member to have 'at the ready,' and be sure you are not running low on your medication.

#### **Evacuation Update Report**

Mayor & Council along with volunteers formed an adhoc Emergency Planning Committee on Monday, June 29<sup>th</sup> @ 10am. By 11am, Mayor & Council declared a State of Local Emergency due to the air quality/heavy smoke coverage and began planning coordination efforts to evacuate priority individuals from the community. The Beauval Nurses provided a list of those priority smoke evacuees and with the help of our volunteers, we prepared the Valley View School Gym as a registration site. By 8pm, the bus was loaded and was off to take 23 Beauval Evacuees including evacuees from Buffalo Narrows and Jans Bay. Our volunteers also started keeping track of those individuals and families who voluntarily evacuated. An additional 5 evacuees were loaded onto a van including individuals from La Loche on June 30<sup>th</sup> and were sent to the Regina evacuation site. If you know of any individuals or families who have evacuated, please contact our Primary Coordinator

Belinda Desjarlais at (306) 288 – 7212 or Secondary Coordinator Janey Yew (306) 288 – 7285 and leave their name and contact number with one of these ladies.

We continue to release updates to our on-air announcer at CIPI Radio and also the Community School; this also includes, now, updates from the English River First Nation – La Plonge reserve. **Our Emergency Committee** will also be meeting daily at 10am until the Local Emergency is lifted and providing updates by 1pm.

We realize that the smoke conditions sometimes improve in our area, but winds can easily shift and we can be covered once again very quickly. We also realize that it may just be as smokey in areas south of here, but the facilities where the evacuees are located are better accommodated to handle people with conditions and also have medical staff on site. We realize these are stressful times but we ask for your understanding and patience as we try to best handle the situation that is before us.

We would like to also take this time to thank the volunteers who have come to stop in at CIPI to offer their services as they were much needed and appreciated. These situations go so much easier with your kind hearted efforts.

## JEMI FIBRE CORP. COMPLETES ACQUISITION OF KISPIOX FOREST LICENSE AND SECURES ADDITIONAL FIBRE SUPPLY IN SASKATCHEWAN

Vancouver B.C., June 30, 2015 - Jemi Fibre Corp. (TSX-V:JFI) ("Jemi Fibre" or the "Company") is pleased to announce that is has completed the acquisition of Forest License A16832 (the "License") as previously announced on March 3rd, 2015.

The License is located in the Kispiox Forest District in the vicinity of Hazelton, British Columbia and the acquisition was completed through an equal joint venture partnership with a British Columbian based, forestry company. The replaceable License has an annual allowable cut of 55.414 cubic metres plus a current undercut of 180,663 cubic The Company metres. anticipates commencing harvesting operation on the License area in the fall of 2015 and in connection with those operations, the Company will commence harvesting 4,000 acres of private timberland it owns in the Hazelton area. These private timberlands were acquired by the Company in connection with its reverse take-over of Dual Enterprises Ltd. in June 2013.

The Company is also pleased to announce that it has entered into a five year agreement with the Northern Village of Beauval, located in northern Saskatchewan, to lease and operate a timber peeling operation and to manage a Crown timber allocation providing for an annual harvest of 40,000 cubic metres. The timber supply for this facility will be maintained through cooperation with Carrier Forest Products, the North West Communities timer allocation, as well as the Company's Crown timber

allocation connected to its Aallcann operations. The Company and the North West Communities intend for this arrangement to provide the seven local communities with long-term, sustainable forestry job opportunities.

"We are pleased to increase our harvesting capacity and fibre supply with these transactions," stated Mike Jenks, Chairman & CEO. "The Kispiox acquisition will enhance our ability to extract value from our own private timberlands in Hazelton and the Beauval agreement lines up our strategy of increasing production from our newly acquired Aallcann wood treatment facility in Saskatchewan.

With these transactions, the Company expects to harvest over 1 450 000 cubic metres of timber on an annual basis, up 630% from the Company's harvesting capacity prior to its acquisitions in June 2014.
